- (2) Setup of Directors (To be submitted to the 162nd Annual General Shareholders' Meeting in late June, 2021)
 - The number of Directors will be changed from twelve to nine to create a lineup commensurate with the clarified roles of the Board of Directors and the execution system and to improve the effectiveness of discussions and accelerate decision-making at the Board of Directors meetings.
 - The number of inside Directors will be changed from seven to five (four will retire from office and two will be appointed), and the number of outside Directors will be changed from five to four (three will retire from office and two will be appointed). As a result, the ratio of outside Directors will change from slightly less than 42% to more than 44%, which will enhance the degree of involvement of outside Directors in the Board of Directors meetings.

- 4. Organizational Reforms Effective April 1, 2021

The existing five business division system will be consolidated to the four business division system.

- To expand the optimization of the overall limestone and carbide chain business at Omi Plant, the Elastomers Dept. in Elastomer and Performance Plastics and the Infrastructure and Social Solutions business will be integrated to establish the Elastomers & Infrastructure Solutions Dept.
- To expand the optimization of the overall supply chain from the manufacturing of monomers to recycling in plastics-related businesses, the Performance Plastics business in Elastomer and Performance Plastics and the Living & Environment Products business will be integrated to establish the Polymer Solutions Dept.
- The Advanced Tape Dept. in Living & Environment Products will be transferred to Electronics & Innovative Products to advance the future business expansion in the automotive area.
