## Denka Establishes Denka Chemicals (Shanghai) Co., Ltd. -Regional headquarters for expanding business and strengthening governance in China-

Denka Company Limited (headquarters: Chuo-ku, Tokyo; president: Toshio Imai; hereinafter "Denka") established Denka Chemicals (Shanghai) Co., Ltd. (hereinafter "DCS"), a new management-focused company(\*), by reorganizing the predecessor of DCS, on September 29, 2021, through the transfer of business operations from the Shanghai Office and two sales bases in Shanghai, with the aim of expanding business and strengthening governance in China.

Denka established the predecessor of DCS in 2004 and subsequently continued to diversify its business in China, with the establishment of regional sales bases in Hong Kong and Taiwan, three production bases, and one research center, in addition to Denka Infrastructure Technologies Shanghai Co., Ltd. and Denka Seiken Shanghai Co., Ltd.

The newly established management-focused company will be in a position to deliver shared services to every base in China and will seek to build the optimal Group management and operation structure and strengthen governance. Moreover, the management-focused company will be positioned as the regional headquarters for the Chinese market, accelerating business expansion focused on Denka's three priority fields: environment and energy, healthcare and high-value-added infrastructure.

With the SDGs as its compass, Denka will continue taking on the challenge of resolving various social issues in ways that only Denka is capable of, with the aim of being truly needed by society and "becoming a company that is irreplaceable to society."
