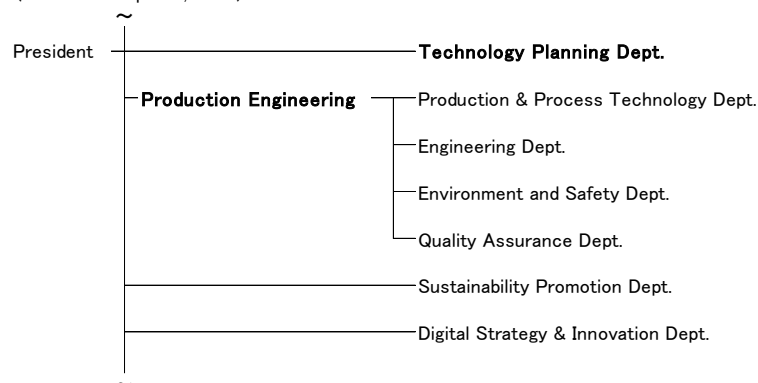

<Restructuring of the technology-related corporate departments>

- To advance the company-wide integrated technology strategy for realizing the “Mission 2030” management plan, we will reorganize the technology-related corporate departments.
